# 2015 TARGETED CALL FOR APPLICATIONS

The Distributing Agency for Sport and Recreation, established in terms of the Lotteries Act (No. 57 of 1997, as amended), is in a position to consider applications for funding from the proceeds of the National Lottery.

In line with Government's commitment to focus on sports development, especially at grassroots level, the Sport and Recreation Distributing Agency (SRDA) will focus on the following areas for funding:

## National Sports Federations can apply for a maximum grant of R 5 000 000 for:

- Transformation & development (a minimum of 50% of the grant being applied for)
- International participation
- Domestic participation
- Capacity building
- Equipment & apparel
- Administration (up to a maximum of 10% of the grant being applied for)

## Provincial Federations can apply for a maximum grant of R 2 500 000 for:

- Transformation & development (a minimum of 50% of the grant being applied for)
- Domestic participation
- Capacity building
- Equipment & apparel
- Administration (up to a maximum of 10% of the grant applied for)

<u>NOTE:</u> National- and Provincial Federations must submit a detailed plan for the transformation & development component of their application.

# <u>Affiliates to Provincial Federations & Districts</u> can apply for a maximum grant of **R 500 000** for:

- Participation in leagues
- Apparel & equipment
- Capacity building
- Transformation & development

## Sports Clubs can apply for a maximum grant of R 300 000 for:

- Participation in leagues
- Equipment & sports apparel
- Administration costs (up to a maximum of 10% of the total grant being applied for)



# <u>Sports NGO's (registered as NPO's or NPC)</u> can apply for a maximum grant of R500 000 for:

• Community empowerment and recreation-based sports programmes.

#### Note: This category applies to organisations whose main objectives are sports-related.

The NLDTF will give preference to applications from organisations that advance the interest of rural, under-privileged and poor communities (including provinces that have historically received less than the prescribed minimum allocation) and support transformation and development.

Applications will be considered from registered or affiliated organisations that submit all the required documents and information as outlined in the **2015 Guidelines**.

### PLEASE NOTE:

- Applicants who have been in existence for less than six (6) months may apply through an agent/representative/conduit.
- Applications from Schools, Sports Councils, Universities, FET Colleges and Sports Academies will not be considered in this call.

Note: The SRDA will also be funding, on a needs basis, certain categories like schools through the proactive funding mechanism outside of the calls for applications in future.

- Late applications.
- Incomplete applications, where **ALL** mandatory documents are not submitted.
- Applications not on the identified prescribed application form
- Faxed or e-mailed applications.
- Applications on Compact Disc (CD).
- Applicants that have not submitted all the required Progress Reports and complied with the provisions of the Grant Agreement on any previous NLDTF funding.
