#### **Conditions of Entry SA Regional Level 3**

1. The SWIMMING SOUTH AFRICA NATIONAL RULES 2023/2024 PUBLISHED IN JANUARY 2023.
2. Gala will be swum in accordance with FINA, SSA Rules
3. Swimmers must be registered before 1st December 2022
4. No unregistered swimmers will be allowed to participate in any SSA sanctioned Gala.
5. Only competitive registered swimmers that has a Level 3 QT. on SSA data base may enter.

#### **General Rules**

6. IPC rules will apply when there are events for Para swimmers at national competitions.
7. All Age Group competitions will be club based.
8. The one start rule will be applied
9. Objections must be submitted in writing up to 30 minutes after the event.
10. An R500.00 fee to be paid with submission of Objections.
11. Referee and Tournament Committee decision will be final.
12. KZNA Swim Board reserve the right to cancel or postpone the gala should there be; Insufficient entries and Reasons beyond their control.
13. The results will be captured and recorded on the KZN data base and SSA data base.
14. Swimmers age is determined by their age on the day of the gala.
15. Referee has the right to consolidate heats as deemed fit.
16. Referee has the right to change event sequence if conditions demand.

25. All technical officials to be correctly attired.
  - a. White top and navy blue longs, shorts or skirts and predominantly white closed shoes.
  - b. It is the responsibility of the CLUB to ensure that their required number of officials submitted report for duty.
  - c. CLUBS are accountable to find a replacement if a given official does not report for duty.
  - d. CLUBS will be fined if the required number of officials does not do duty on that day.
  - e. Official duty roster must be submitted with gala entries, if not, then gala entries will not be captured.
  - f. Officials are classified as Judges or Time keepers;
