1. Up and running districts must at least have an education and training coordinator who will manage the unit. All E&T requirements must be communicated with the provincial coordinator who will then communicate with SSA.

- 2. All E&T requirements must be communicated three weeks in advance to avoid hiccups and disappointments
- 3. After all the registers and reports have been submitted, the province must invoice the district for their portion.
- 4. The costs for the first exam and the first practical assessment must be covered by the affiliate as both are covered within the course fee.
- 5. The second exam (re-write) and the second practical assessment must be covered by the candidate as indicated above.

- 6. Todswim & LTS candidates usually write on the last day of the course. If written at a later stage affiliate would have to pay an invigilator R200 a session.
- 7. Level 1 coaching exams are written 2 weeks after the course as would be arranged by the affiliate. Invigilation costs must be covered by affiliate at R300 a session.
- 8. If there is a need for an oral exam, it must be discussed with the federation. If it is a re-write, the candidate will have to cover the costs, which will be at R150 for all courses.
- 9. Re-printing of any certificate that has not expired is R150; SSA will not print an expired certificate.
- 10. Upgrades will cost R200 and the affiliate retains R50 and SSA will invoice the affiliate R150
